

ORDINANCE NO. 0-86-49

AN ORDINANCE AMENDING SECTION 4.36.02 AND 4.36.08 OF THE CONWAY MUNICIPAL CODE; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section One: The portion of Section 4.36.02 of the Conway Municipal Code dealing with minimum limits of liability is hereby amended to read as follows: "If the accident has resulted in bodily injury or death, to a limit, exclusive of interest and costs, of not less than Twenty Five Thousand (\$25,000.00) Dollars because of bodily injury to or death of one (1) person in any one (1) accident and subject to said limit for one (1) person, to a limit of not less than Fifty Thousand (\$50,000.00) Dollars because of bodily injury to death of two (2) or more persons in any one (1) accident, and if the accident has resulted in injury to, or destruction of property, to limit of not less than Fifteen Thousand (\$15,000.00) because of injury to or destruction of property of others in one (1) accident."

Section Two: The rate schedule of Section 4.36.08 of the Conway Municipal Code is hereby amended to read as follows:

1. For transporting one passenger from a point of origin in one zone to a destination in the same zone, \$2.00.
2. When a passenger is transported from a point of origin in one zone to a destination in another zone, an additional charge may be levied in the sum of 50¢ for each additional zone or part of a zone.
3. For each additional passenger in excess of one being transported from the same point of origin to the same destination, an additional charge may be made in the sum of \$1.00.

4. For each piece of luggage or parcel in excess of three, an additional charge may be made in the sum of 25¢.

5. For members of the same family going to the same destination the sum of 50¢ per family member with children under six (6) years of age riding free, when accompanied by a paying passenger.


6. For each five (5) minutes of waiting time, an additional charge may be made in the sum of 50¢.

7. For delivery of drugs or other items from one point of origin to one point of destination will be \$2.00 plus 50¢ per zone.


8. The hours of operation are to be a minimum of 12 hours each day and as follows: 6 a.m. to 6 p.m., Monday through Saturday.
