

ORDINANCE NO. 0-91- 34

AN ORDINANCE AMENDING SECTIONS OF CHAPTER 5.04 OF THE CONWAY MUNICIPAL CODE; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That Section 5.04.03 Subsection (a) is hereby amended to read as follows: .

"Each separate retail or wholesale business or commercial establishment, as hereinafter defined, a fee of not less than \$12.00 per month shall be collected. The amount of the fee to be charged any such establishment shall be \$2.00 per stop plus \$2.00 per yard, having due regard to the quantity, type and weight of garbage collected therefrom. The term "business or commercial establishment" as used herein is defined to include any person, firm or corporation engaged in displaying, selling, buying or servicing of goods, wares, merchandise or other property, or the rendering or receiving of professional services, and including, but not limited to banks, barber shops, beauty parlors, department stores, markets, motor vehicle service stations, garages, offices, radio stations, supermarkets, telephone exchanges, theaters, repair shops, and livestock auction barns."

Section 2: That Section 5.04.04 Subsection (b), (c), and (d), are hereby amended to read as follows:

"(b) Any person, firm or corporation situated within the corporate limits of the City of Conway but which is excepted from the provisions of this ordinance with regard to subscription to the collection and transportation of garbage in Section 5.04.03 hereof, which desires to transport its garbage to and dump the same upon the city's sanitary landfill shall be permitted to do so and the following schedule of fees is hereby established for the exercise of that privilege:

Auto and Pickup	\$ 6.00
Single axle trailers	\$ 7.00
Dual axle trailers	\$10.00
Single axle bob trucks	\$14.00
Dual axle trucks and long trailers	\$24.00
\$2.00 per yard (uncompacted) and	
\$4.00 per yard (compacted)"	

"(c) Any person, firm or corporation situated outside the corporate limits of the City of Conway which is engaged in the operation of an industrial plant, wherein the activities therein carried on consist of assembling, fabricating, furnishing, manufacturing, packaging or other processing, and which desires to transport its garbage to and deposit the same upon the city's sanitary landfill shall be permitted to do so and the following schedule of fees is hereby established for the exercises of that privilege:

Auto and pickup	\$ 6.00
Single axle trailers	\$ 7.00
Dual axle trailers	\$10.00

Each mobile home or house trailer  
not situated in mobile home park \$6.50  
Each mobile home or house trailer  
situated in mobile home park \$6.50  
Each separate dwelling unit owned and  
operated by the Conway Housing  
Authority or other such public agency \$6.50"

Section 4. That Section 5.04.11 be amended to read as follows:

"Collection. Garbage shall be collected from businesses, houses and other such establishments each day except Sunday and holidays and from dwelling houses and homes once each week on designated routes and schedules; and it is hereby made the duty of the persons having garbage on their premises to place it within 5 feet of the curb/street where it may be easily reached by the city garbage employees."

Section 5. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of that conflict.

Section 6. That it is ascertained and declared that it is necessary for the public peace and welfare of the citizens of the City of Conway, Arkansas, an emergency is hereby declared to exist, and this ordinance shall take effect and be in force from and after its passage and publication.
