## ORDINANCE NO. 0-94-/

AN ORDINANCE AMENDING THE **1994** CITY OF CONWAY BUDGET; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

WHEREAS, the Mayor of the City of Conway has submitted to the City Council amendments to the 1994 budget; and

WHEREAS, the amendments reflect raises in police and fire salaries for the Grade 12, Step 1, 2, and 3 positions to be raised to Step 4.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. The sum of \$87,681 is hereby appropriated from Unappropriated General Fund Reserves to the Police Department Budget and the sum of \$33,261 is hereby appropriated from Unappropriated General Fund Reserves to the Fire Department Budget.

SECTION 2. The Mayor is directed to cause the proper accounting entries to be made in the books and records of the City to reflect this admendment for the fiscal year effective 3-6-94.

SECTION 3. That all ordinance in conflict herewith are repealed to the extent of the conflict.

SECTION 4. That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

## ORDINANCE NO. 0-94- /6

AN ORDINANCE WAIVING BIDS AND APPROPRIATING FUNDS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

WHEREAS, the City Council desires to purchase additional land for the Landfill area; and

WHEREAS, negotiations have taken place for available property adjacent to the existing Landfill property; and

WHEREAS, agreements have been reached with two property owners with a combined price of \$71,666.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. Bids are waived for the purchase of property adjacent to the existing Landfill site in order to purchase property at a negotiated cost of \$71,666.

SECTION 2. The sum of \$71,666 is hereby appropriated from Unappropriated General Fund Reserves in order to purchase two parcels of property adjacent to the existing Landfill site.

SECTION 3. That all ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 4. That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
