ORDINANCE NO. O-99- 53 by _____ D. C.

**AN ORDINANCE ACCEPTING THE ANNEXATION OF
CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS;
DECLARING AN EMERGENCY;
AND FOR OTHER PURPOSES**

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 8th day of June, 1999, said territory being situated in Faulkner County, Arkansas, and described as follows:

Being a part of the SW1/4 NW1/4 of Section 23, T5N, R14W, Faulkner County, Arkansas, described as beginning at the NE corner of said SW 1/4, NW 1/4; thence S-0-18-0-W 1326.78 feet to the SE corner of said SW 1/4, NW 1/4; thence West 329.36 feet; thence N-0-14-30-E, 663.51 feet; thence West 640.01 feet; thence N-0-14-30-E, 663.41 feet to the North line of said SW 1/4, NW 1/4, said point being 350.06 feet East of the NW corner of said SW 1/4, NW 1/4; thence along said North line, East 970.71 feet to the point of beginning, containing 19.80 acres more or less.

and that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas, and shall be zoned **R-1**.

SECTION 2: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations, and regulations imposed upon the inhabitants within the original limits of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as a part of Ward 1 of the City of Conway, Arkansas.

SECTION 3: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing

ordinance be passed and adopted; that an emergency exists; that this ordinance shall take effect and be in force from and after its passage and publication.
