**ORDINANCE NO O-05-167**

**AN ORDINANCE ACCEPTING DONATIONS AND APPROPRIATING FUNDS FOR EMPLOYEE APPRECIATION; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES**

WHEREAS, the City of Conway has received community donations in support of the Employee Appreciation Party; \$8,545 in donations for the express purpose of funding the Employee Appreciation Party have been received and deposited in the donations account; and

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**

**SECTION 1.** The City of Conway shall accept donations in the amount of \$8,545 (01.909) and shall appropriate the same amount to the Administration Other Programs account (01.101.298) for the purpose of covering the cost of the Employee Appreciation Party. .

**SECTION 2.** All ordinances in conflict herewith are repealed to the extent of the conflict.




