ORDINANCE NO. O-05-32

**AN ORDINANCE ACCEPTING A RECYCLING AWARD AND
APPROPRIATING FUNDS FOR SANITATION DEPARTMENT
IMPROVEMENTS; DECLARING AN EMERGENCY; AND FOR OTHER
PURPOSES:**

WHEREAS, the Sanitation Department of the City of Conway has been awarded \$5,000 by the Novelis Corporation as an award in a "Cash Back for Cans" competition recognizing the City of Conway's recycling efforts; and

WHEREAS, the Sanitation Department is in need of a reuse center for Household Hazardous Waste/EWaste;

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF CONWAY, ARKANSAS, THAT:**

SECTION 1. The City of Conway shall accept award revenue totaling \$5,000 from the Novelis Corporation (50.910) and shall appropriate the same amount for a reuse center for household hazardous waste (50.118.915)

SECTION 2. All ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 3. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
