AN ORDINANCE ADOPTING A BUDGET FOR THE CITY OF CONWAY, ARKANSAS, FOR THE FISCAL YEAR JANUARY 1, 2011 THROUGH DECEMBER 31, 2011, AND PROVIDING THAT THE AMOUNTS STATED IN THE BUDGET DOCUMENT AS ADOPTED EXPENDITURES SHALL BECOME APPROPRIATED FOR THE VARIOUS FUNCTIONS AND ACTIVITIES SPECIFIED IN SAID BUDGET DOCUMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

WHEREAS, the Mayor of the City of Conway has submitted to the City Council a BUDGET FOR THE FISCAL YEAR 2011;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. A Budget for the fiscal year 2011 for the City of Conway, Arkansas, as set forth in the document entitled "City of Conway FY 2011 Budget"; providing a total appropriation for the following funds:

General Fund	25,830,267
Street Fund	4,363,500
Sanitation Enterprise Fund	7,147,200
Sanitation Replacement Fund	1,775,000
Conway Non-Uniformed	1,070,000
Special Revenue Fund	4,550,000
CDBG Fund	500,000
Capital Project Fund 34 Street	2,500,000
Capital Project Fund 39 Trail	1,200,000
Debt Service	5,216,920
Total	54,152,887

SECTION 2. From the effective date of the budget, to wit: January 1, 2011, the several amounts as stated therein as adopted expenditures shall be and are hereby appropriated for the several purposes, functions and activities within the various departments, offices and agencies specified therein.

SECTION 3. The Mayor is directed to cause the proper accounting entries to be made in the books and records of the City so as to reflect the appropriations for the aforesaid fiscal year, and he is further directed to file a certified copy of the adopted budget for the fiscal year with the City Clerk of the City of Conway, Arkansas.

SECTION 4. All ordinances in conflict herewith are repealed to the extent of that conflict.

SECTION 5. This ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage and approval.
