AN ORDINANCE APPROPRIATING FUNDING FOR THE NEW NON-UNIFORM PENSION PLAN; DECLARING AN EMERGENCY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

Whereas, the City of Conway has formally adopted a new Non-Uniform Pension Plan to take effect May 1, 2018; and

Whereas, the City's contributions under the new Plan will increase from 6% to 10% of participant employee pay; and

Whereas, the budget for the fiscal year 2018 must be amended for this increase in contributions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funding from the respective funds' Fund Balance Appropriation accounts (xxx-xxx-4900) into the respective departmental Nonuniform Retirement expenditure accounts (xxx-xxx-5150), outlined as follows:

General Fund	\$160,520
Street Fund	53,570
Sanitation Fund	88,380
Airport Fund	<u>5,462</u>
Total	\$307,932

Section 2. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 3. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.


