AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

Whereas, the City of Conway has received reimbursements funds from the following entities:

Various Companies	\$8,805.29	Extra Duty Services
AR State Police	\$969.16	Taskforce Funds
Various Companies	\$2,000.00	Child Safety Fair
Various Companies	\$106.75	Insurance Proceeds
DEA/Marshall	\$905.45	Taskforce Funds

Whereas, the Conway Police Department needs these funds to replenish their expenditure accounts;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funds from Various Companies in the amount of \$8,805.29 from 001.121.4185 to the CPD overtime expense account, 001.121.5114.

Section 2. The City of Conway shall appropriate funds from ASP in the amount of \$969.16 from 304.000.4201 to the CPD overtime expense account 001.121.5114.

Section 3. The City of Conway shall appropriate funds from various companies in the amount of \$2,000 from 001.121.4705 to the CPD Child Safety Fair expense account 001.121.5450.

Section 4. The City of Conway shall appropriate funds from various companies in the amount of \$106.75 from 001.121.4186 to the CPD Other Miscellaneous expense account 001.121.5799.

Section 5. The City of Conway shall appropriate funds from Federal funds in the amount of \$905.45 from 001.121.4186 to the CPD overtime expense account 001.121.5114.

Section 6. All ordinances in conflict herewith are repealed to the extent of the conflict.

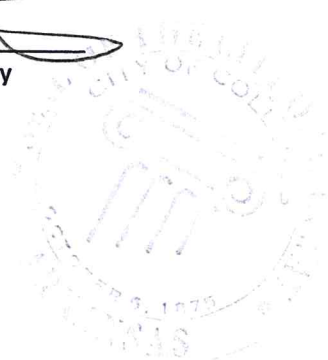
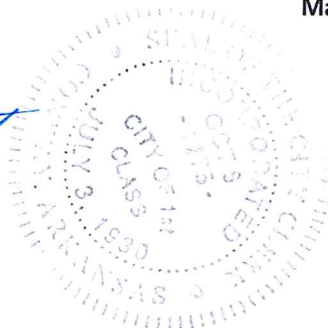
