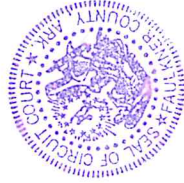

Ordinance No. O-19-93

AN ORDINANCE ACCEPTING FEDERAL FUNDING, APPROPRIATING GRANT REVENUE & APPROVING CONTRACTS FOR SERVICES FOR THE CONWAY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM, DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

Whereas, the Department of Housing and Urban Development (“HUD”) has awarded grant funds to the Community Development Block Grant (“CDBG”) in the amount of \$472,390 for FY2019 funding; and

Whereas, each nonprofit agency receiving funding must enter into an agreement with the Community Development Block Grant Program.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall accept grant proceeds from HUD in the amount of \$472,390 for CDBG activities.

Section 2. The City of Conway shall appropriate \$472,390 to the following projects:

\$200,000.00	Acquisition/Remodel of Property for a Homeless Shelter
\$107,053.50	5 th Avenue Playground Renovations
\$94,478.00	Administration
\$19,131.80	Boys & Girls Club of Faulkner County - Transportation
\$17,218.62	Faulkner County Council of Aging – Transportation
\$15,199.15	Independent Living Services - Transportation
\$5,030.95	Young Empowered Sister (Y.E.S.) – Transportation
\$4,038.93	Milestones – Transportation
\$3,046.92	Bethlehem House Transportation - Transportation
\$3,046.92	Women Shelter of Central Arkansas – Transportation
\$2,550.91	HAVEN – Transportation
\$1,594.32	Conway Ministry Center – Warming Center

Section 3. The City of Conway shall approve entering into agreements with all the agencies listed above for the Program Year 2019.

Section 4. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 5. This ordinance is necessary for the protection of the peace, health, and safety of the citizens of Conway, and therefore, an emergency is declared to exist, and this ordinance shall go into effect from and after its passage and approval.



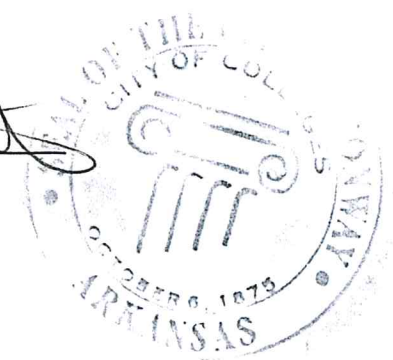
