**AN ORDINANCE TO WAIVE THE COMPETITIVE BID PROCESS FOR THE DEMOLITION TWO BUILDINGS ON VAN RONKLE STREET FOR THE CONWAY TRANSPORTATION DEPARTMENT; AND FOR OTHER PURPOSES**

**Whereas**, the City of Conway has an immediate need to demolish the buildings located at 1010 and 1012 Van Ronkle, Conway AR 72032; and

**Whereas**, the City of Conway previously budgeted funds for this project in the Pay as You Go Sales and Use Fund; and

**Whereas**, the City of Conway solicited bids for this project and did not receive any bids; therefore, wish to request that Council waive the competitive bid process; and

**Whereas**, Graylee Construction has quoted this demolition in the amount of \$60,750.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**

**Section 1.** The City of Conway shall waive the competitive bid process and approve the demolition of 1010 & 1012 Van Ronkle from Graylee Construction for \$60,750.

**Section 2.** All ordinances in conflict herewith are repealed to the extent of the conflict.

**Section 3.** This ordinance is necessary for the protection of the peace, health, and safety of the citizens of Conway, and therefore, an emergency is declared to exist, and this ordinance shall go into effect from and after its passage and approval.

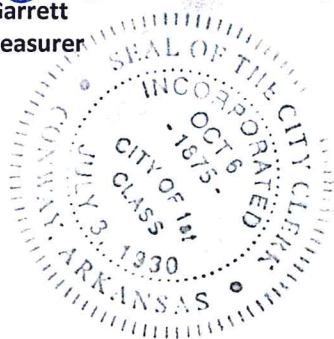
