AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

Whereas, the City of Conway has received reimbursements funds from the following entities:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funds from various companies in the amount of \$42,228.47 from 001.121.4185 to the CPD overtime acct 001.121.5114.

Section 2. The City of Conway shall appropriate funds from ASP in the amount of \$490.31 from 304.000.4201 to the CPD overtime acct. 001.121.5114.

Section 3. The City of Conway shall appropriate funds from Nationwide Insurance in the amount of \$662.53 from 001.121.4186 to the CPD Other Miscellaneous account 001.121.5799.

Section 4. The City of Conway shall appropriate funds from Municipal Vehicle Program in the amount of \$1,501.95 from 001.119.4360 to the CPD vehicle maintenance acct. 001.121.5450.

Section 5. The City of Conway shall appropriate funds from various companies in the amount of \$6,198.72 from 001.121.4705 to the CPD grant and donation acct. 001.121.5760.

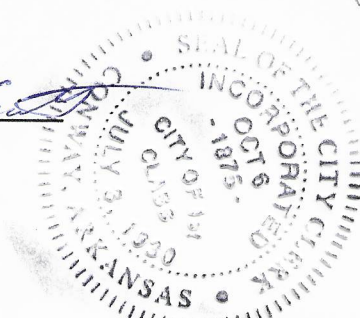

Section 7. All ordinances in conflict herewith are repealed to the extent of the conflict.



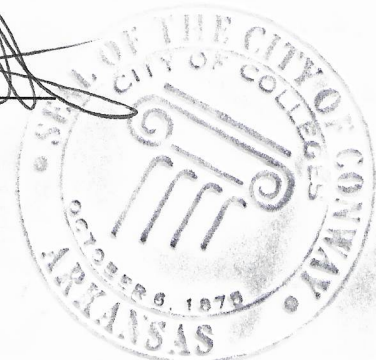
