AN ORDINANCE AUTHORIZING THE RESTRUCTURING AND THE ADDITION, REVISION, OR RECLASSIFICATION OF CERTAIN TITLES AND SALARIES; AND UPDATING THE AUTHORIZED POSITION LIST FOR THE OFFICE OF THE CITY ATTORNEY; AND FOR OTHER PURPOSES:

Whereas, the Office of the City Attorney requests restructuring of the department and the addition, revision, or reclassification of certain titles and salaries to support recruitment and retention of

Whereas, a restructure of the office will also provide for greater support for the attorneys in the office, facilitate cross training among the staff level positions, and provide a more responsive office to the public and City employees, council members, commissioners and board members; and

Whereas, all changes to staff and salary will be budget neutral; and

Whereas, the Office of the City Attorney requests an updated Authorized Position List as a result of the restructuring.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall make the following changes to the Office of the City Attorney:
