City of Conway, Arkansas
Ordinance No. O-20-71

**AN ORDINANCE APPROPRIATING INSURANCE PROCEEDS FOR EMERGENCY BUILDING MAINTENANCE;
 DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES**

WHEREAS, the Conway Fire Department requests \$26,765 for the use of Emergency repair for Station 1's roof and interior damage due to wind and rain; and

WHEREAS, funds in the amount of \$26,765.19 were received from the Municipal Insurance Program for such reasons; and

WHEREAS, Southern Home Restoration and Roofing LLC (SOHO Roofing, LLC) worked with Municipal League's Insurance Adjuster to expedite emergency repair and damage control; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate \$26,765.19 from the Insurance Proceeds Account (001.119.4360) to the Fire Department Fire Department Building Maintenance Operating Account (01.131.5410);

Section 2. The City of Conway shall waive the bid process due to emergency repair and approve Southern Home Restoration and Roofing LLC (SOHO Roofing LLC) to complete repairs;

Section 3. All ordinances in conflict herewith are repealed to that extent of the conflict.

Section 4. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

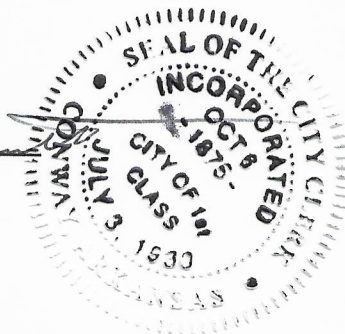
