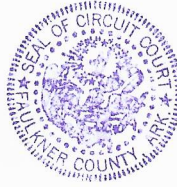

ORDINANCE



City of Conway, Arkansas
Ordinance No. O-20-72

AN ORDINANCE APPROVING THE LOW BID FOR A MOBILE AMMUNITION COMBUSTION SYSTEM FOR THE CONWAY FIRE DEPARTMENT BOMB SQUAD, AND FOR OTHER PURPOSES:

Whereas, Conway Fire Department has been awarded a grant in the amount of \$451,696 by the Arkansas Department of Emergency Management (ADEM) as the State Administrative Agency (SAA) for the Homeland Security Grant Program (HSGP) from the Department of Homeland Security Federal Emergency Management Agency (DHS FEMA) as a recipient for the FY20 Homeland Security Grant Program under the Law Enforcement Terrorism Prevention Activities (LETPA) category; and

Whereas, the Conway City Council accepted this 100% reimbursable grant through O-20-63 and appropriated these funds into the 2020 budget at that time; and

Whereas, the City of Conway solicited bids for a Mobile Combustion System and received one qualified bid from TWB Designs in the amount of \$350,725.15.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall accept the lowest bid from TWB Designs and expend budgeted funds in the Grant Machinery and Equipment expense account (399.131.5910).


Section 2. All ordinances in conflict herewith are repealed to the extent of the conflict.

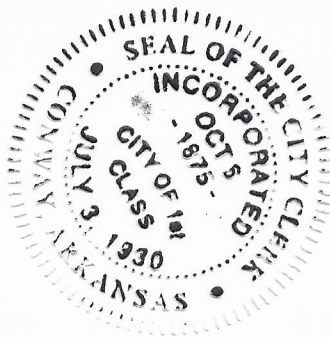
