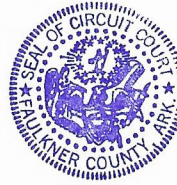

Ordinance No. O-21-116**

**AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR
THE CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES**

Whereas, the City of Conway has received reimbursements funds from the following
entities:

Various Companies	\$21,003.84	Extra Duty Services
Municipal Vehicle Program	\$876.62	Insurance Proceeds
Various Companies	\$1,500.00	Donations (Cops and Coats)

Whereas, the Conway Police Department needs these funds to replenish their
expenditure accounts.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY,
ARKANSAS THAT:**

Section 1. The City of Conway shall appropriate funds from Various Companies in the
amount of \$21,003.84 from 001.121.4185 to the CPD overtime expense account, 001.121.5114.

Section 2. The City of Conway shall appropriate funds from Municipal Vehicle Program
in the amount of \$876.62 from 001.119.4360 to the CPD vehicle maintenance expense account
001.121.5450.

Section 3. The City of Conway shall appropriate funds from various companies in the
amount of \$1,500.00 from 001.121.4705 to the CPD grant and donation expense account
001.121.5760.

Section 4. All ordinances in conflict herewith are repealed to the extent of the conflict.

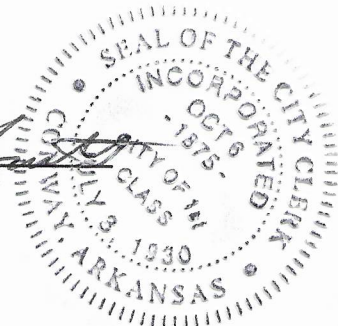
