**City of Conway, Arkansas  
Ordinance No. O-21-22**

**AN ORDINANCE APPROVING PROFESSIONAL SERVICES FOR A 12-Bay T-HANGAR BUILDING FOR  
CANTRELL FIELD AIRPORT; AND FOR OTHER PURPOSES:**

**Whereas**, the City of Conway would like to enter into an agreement with Garver in accordance with the provisions of the Master Agreement for Professional Services executed on July 8, 2019 for the construction of a 12-Bay T-Hangar Building; and

**Whereas**, this work order will include project administration, final design, bidding services and construction phase services. The total fee is \$57,000; and

**Whereas**, the City of Conway intends to apply for a grant in the amount of \$250,000 with Arkansas Department of Aeronautics state matching grant (80%/20%) to cover cost associated with this project.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS  
THAT:**

**Section 1.** The City of Conway shall approve the Work Order from Garver in the amount of \$57,000.

**Section 2.** The City of Conway shall apply for a reimbursing, matching grant from Arkansas Department of Aeronautics.


**Section 3.** All ordinances in conflict herewith are repealed to the extent of the conflict.

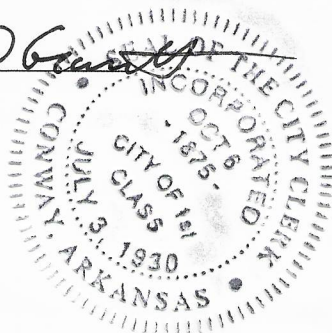
