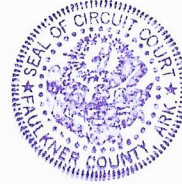

Ordinance No. O-21-24

AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

WHEREAS, the City of Conway received reimbursements funds from the following entities in fiscal year 2020:

Various Companies	\$13,753.05	Extra Duty Services
AR State Police	\$2,261.50	Taskforce Funds
Nationwide Insurance	\$342.48	K9 vet check reimbursement
DEA/Marshall	\$10,907.96	Taskforce Funds

WHEREAS, the Conway Police Department needs these funds to replenish their expenditure accounts in fiscal year 2020.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

SECTION 1. The City of Conway shall appropriate funds from Various Companies in the amount of \$13,753.05 from 001.121.4185 to the CPD overtime expense account, 001.121.5114.

SECTION 2. The City of Conway shall appropriate funds from Arkansas State Police in the amount of \$2,261.50 from 304.000.4201 to the CPD overtime expense account 001.121.5114.



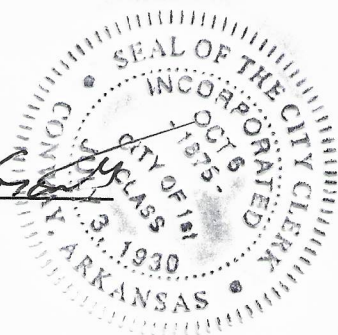

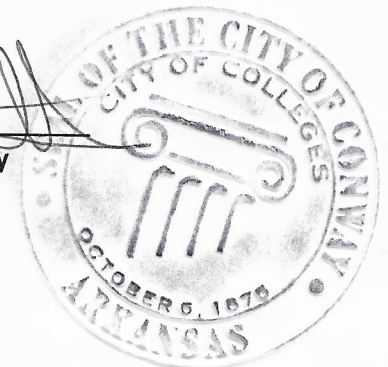
