**AN ORDINANCE AUTHORIZING EXPENDITURE OF FUNDS FOR THE CONWAY PUBLIC ART  
MASTER PLAN; APPROPRIATING FUNDS FOR THE CONWAY PUBLIC ART BOARD; AND FOR  
OTHER PURPOSES:**

**WHEREAS**, the Conway Public Art Board issued a request for proposals for a consultant to develop a Public Art Master Plan; and

**WHEREAS**, Designing Local, LTD responded to the request for proposals and was selected by the Conway Public Art Board; and

**WHEREAS**, the Conway Public Art Board decision to select Designing Local, LTD. was accepted by the City Council.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY,  
ARKANSAS THAT:**

**Section 1.** That the City of Conway, Arkansas by Mayor Castleberry is authorized to enter into an agreement and sign all necessary documents with Designing Local, LTD. to prepare a Public Art Master Plan.

**Section 2.** The City of Conway shall appropriate \$49,938 for the Public Art Master Plan from 221.140.4900 Fund Balance to 221.140.5990 CIP-Misc.

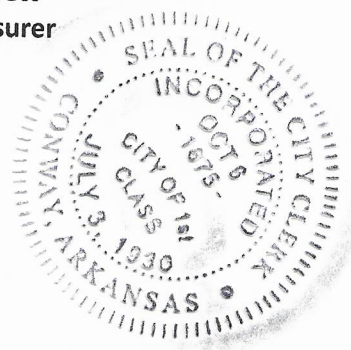
