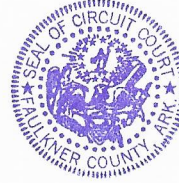

City of Conway, Arkansas
Ordinance No. O-22-26

AN ORDINANCE APPROPRIATING FUNDING AND ACCEPTING THE LOWEST QUALIFIED BID FOR THE REMODEL OF 1116 GUM STREET PROPERTY FOR THE OVERNIGHT EMERGENCY SHELTER; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES;

Whereas, the Community Development Department solicited bids for the remodel of an office building located at 1116 Gum Street for the Overnight Emergency Shelter; and

Whereas, three bids were submitted for the remodel project; and

Whereas, Frank A. Rogers Company Inc. submitted the lowest qualified bid for the project in the amount of \$2,065,746; and

Whereas, this project will be partially funded from the Community Development Block Grant Program Year funding and from the City's American Rescue Plan funding.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall accept the bid from BMD Builders in the amount of \$2,065,756 for the Overnight Emergency Shelter Remodel Project.


Section 2: The City of Conway shall appropriate an amount not to exceed \$700,000 from the Grant Fund Balance Appropriation Account (399.000.4900) to the Grant Fund CIP - Misc. Account (399.000.5990) for the American Rescue Plan portion of the Overnight Emergency Shelter.

Section 3. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 4. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

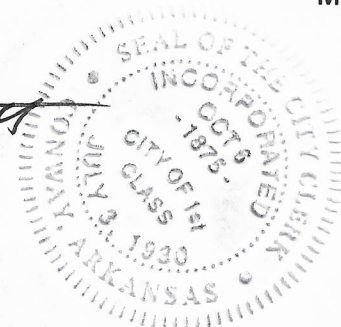
