ORDINANCE



**City of Conway, Arkansas
Ordinance No. O-22-28**

AN ORDINANCE APPROPRIATING FUNDS TO ACQUIRE THE BUILDING LOCATED AT 450 CORPORATE DRIVE, CONWAY AR 72032 FOR THE FUTURE CONWAY COMMUNITY CENTER; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

Whereas, a special election was held on February 8th, 2022 and the public approved a rededication of the Advertising and Promotion bonds for a Community Center & Soccer Complex; and

Whereas, The City Council previously authorized the Mayor to enter into a contract with Acxiom (IPG) to purchase the building located at 450 Corporate Drive for the Conway Community Center; and

Whereas, the cost for the building located at 450 Corporate Drive will be \$2,750,000.00; and

Whereas, after the bond issue is closed, the City will reimburse itself from the Construction Fund for the cost of the building.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1: The City of Conway shall appropriate funds in the amount of \$2,750,000 plus \$8,500 in estimated closing cost from the Parks and Recreation A&P Transfers In Account (252.000.4800) to the Parks & Recreation A&P Building Acquisition Account (252.140.5903) for the purchase of the building located at 450 Corporate Drive.

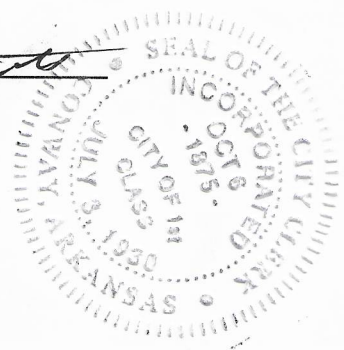
Section 2. That this ordinance shall be in full force and effect from and after its passage
