ORDINANCE



City of Conway, Arkansas
Ordinance No. O-22- 52

AN ORDINANCE APPROPRIATING FUNDS TO REPLACE THE BATTERY BACKUP SYSTEM AT THE CONWAY EMERGENCY OPERATIONS CENTER (CEOC); DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

Whereas, the primary battery backup system at the Emergency Operations Center is at the end of its useful life and in need of replacement; and

Whereas, this system ensures that all computers and technical equipment used by dispatchers stays on and operable in the event of a power outage until the backup generator can re-establish facility wide power; and

Whereas, the City recommends Council approve Data Spaces to the replacement battery backup system, therefore, it is the desire of the City that Council to waive bids; and

Whereas, the total expected cost is \$66,500, this is not included in the 2022 General Fund Budget; and

Whereas Faulkner County contributed half the cost of the system replacement in the 2020 fiscal year; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funds in the amount of \$66,500 from the General Fund Balance Appropriation Account (001.119.4900) to the CEOC Computer Equipment account (001.125.5930).

Section 2. The City of Conway shall waive the bid process and approve Data Spaces for the above states project and service.

Section 3. All ordinances in conflict herewith are repealed to that extent of the conflict.

Section 4. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

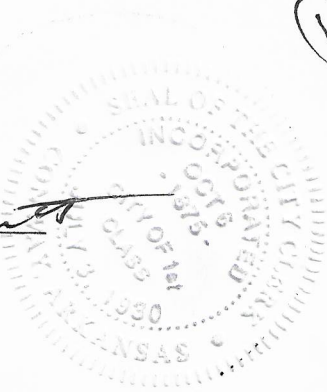
