## AN ORDINANCE APPROPRIATING FUNDS TO REPLACE THE BATTERY BACKUP SYSTEM AT THE CONWAY EMERGENCY OPERATIONS CENTER (CEOC); DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

Whereas, the primary battery backup system at the Emergency Operations Center is at the end of its useful life and in need of replacement; and

Whereas, this system ensures that all computers and technical equipment used by dispatchers stays on and operable in the event of a power outage until the backup generator can re-establish facility wide power; and

Whereas, the City recommends Council approve Data Spaces to the replacement battery backup system, therefore, it is the desire of the City that Council to waive bids; and

Whereas, the total expected cost is \$66,500, this is not included in the 2022 General Fund Budget; and

Whereas Faulkner County contributed half the cost of the system replacement in the 2020 fiscal year; and

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

- **Section 1**. The City of Conway shall appropriate funds in the amount of \$66,500 from the General Fund Balance Appropriation Account (001.119.4900) to the CEOC Computer Equipment account (001.125.5930).
- **Section 2.** The City of Conway shall waive the bid process and approve Data Spaces for the above states project and service.
  - Section 3. All ordinances in conflict herewith are repealed to that extent of the conflict.

**Section 4.** This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
