ORDINANCE

AN ORDINANCE AMENDING ORDINANCE NO. O-08-111 AND EXTENDING THE FRANCHISE OF THE CONWAY CORPORATION TO OPERATE A CABLE TELECOMMUNICATIONS PLANT AND FACILITIES OF THE CITY OF CONWAY, ARKANSAS.

WHEREAS, the City of Conway, Arkansas (the "City"), a city of the first class, presently owns a Telecommunications Plant (as defined in Ordinance No. O-08-111) serving the residents of the City, which Telecommunications Plant is presently operated and maintained by the Conway Corporation, a nonprofit corporation organized and existing under the laws of the State of Arkansas (the "Corporation"), pursuant to an exclusive franchise to operate and maintain the Telecommunications Plant granted to the Corporation by the City pursuant to Ordinance No. O-08-111 adopted on September 23, 2008; and

WHEREAS, the City desires to extend the term of the franchise previously granted to the Corporation;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Conway, Arkansas that:

**Section 1.** The term of the franchise granted to the Corporation by Ordinance No. O-08-111 is hereby extended to December 31, 2050 and Section 2 of Ordinance No. O-08-111 is hereby deemed amended to such effect. All other provisions of Ordinance No. O-08-111 shall remain in full force and effect.

**Section 2.** The extension of franchise granted by this Ordinance shall be accepted in writing by the Corporation within thirty (30) days from the date of adoption of this Ordinance, whereupon the franchise shall be deemed to be extended as provided in Section 1.

**Section 3.** The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared to be illegal or invalid, such declaration shall not affect the validity of the remainder of the sections, phrases or provisions of this Ordinance.

**Section 4.** All ordinances, resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.
