# AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

Whereas, the City of Conway has received reimbursements funds from the following entities:

Various Companies	\$51,139.44	Extra Duty Services
DEA/Marshall	\$8,819.91	Taskforce Funds
Municipal Vehicle Program	\$7,806.94	Insurance Proceeds
Gall's Uniforms	\$1,632.79	Overpayment

Whereas, the Conway Police Department needs these funds to replenish their expenditure accounts.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

**Section 3.** The City of Conway shall appropriate funds from Municipal Vehicle Program in the amount of \$7,806.94 from 001.119.4360 to the CPD vehicle maintenance expense account 001.121.5450.

**Section 4.** The City of Conway shall appropriate funds from Gall's in the amount of \$1,632.79 from 001.121.4186 to the CPD uniforms expense account 001.121.5670.
