**AN ORDINANCE APPROPRIATING REIMBURSEMENT FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES**

**Whereas**, the City of Conway has received reimbursement funds from the following entities in the fiscal year 2023:

**Section 2.** The City of Conway shall appropriate funds from various companies in the amount of \$250.00 from 001.121.4705 to the CPD grant and donation expense account 001.121.5760.



**Section 5.** All ordinances in conflict herewith are repealed to the extent of the conflict.

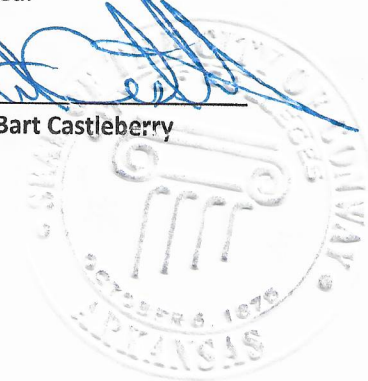
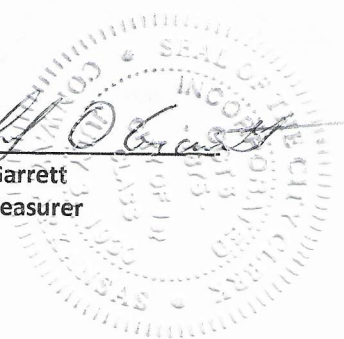
