**Ordinance No. O-24-14**

**AN ORDINANCE AUTHORIZING A RECLASSIFICATION OF A PROGRAM & MARKETING MANAGER TO A SOCCER COMPLEX OPERATIONS MANAGER FOR THE CONWAY PARKS AND RECREATION DEPARTMENT; AND OTHER PURPOSES**

**Whereas**, the Conway Parks and Recreation Department will soon open and operate a new lighted ten (10) field Soccer Complex to be located on 2100 Museum Road; and

**Whereas**, the Conway Parks and Recreation Department has determined that there is a need to reclassify a Program & Marketing Manager to a Soccer Complex Operations Manager with a salary of \$55,000; and

**Whereas**, no budget adjustment is required for the remainder of the 2024 budget year.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**

**Section 1.** The City of Conway shall reclassify one Program and Marketing Manager position to a Soccer Complex Operations Manager with a starting salary of \$55,000.

**Section 2.** No additional salary funds are required for these additions.


**Section 3.** All ordinances in conflict herewith are repealed to the extent of the conflict.


