**City of Conway, Arkansas**  
**Ordinance No. O-24-23**

**AN ORDINANCE ACCEPTING GRANT PROCEEDS AWARDED TO THE CONWAY FIRE DEPARTMENT BOMB SQUAD, WAIVING THE COMPETITIVE BIDS PROCESS, AND FOR OTHER PURPOSES:**

**Whereas**, Conway Fire Department has been awarded two grants. One in the amount of \$76,204 (Community Preparedness) and one in the amount of \$301,976 (Bomb), both by the Arkansas Department of Emergency Management (ADEM) as the State Administrative Agency (SAA) for the Homeland Security Grant Program (HSGP) from the Department of Homeland Security Federal Emergency Management Agency (DHS FEMA) as a recipient for the FY23 Homeland Security Grant Program; and

**Whereas**, the Conway Fire Department Bomb Squad requests acceptance of these grants in order to purchase equipment and training.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**


**Section 1.** The City of Conway shall budget grant funds of \$378,180 in the Federal Grant Fund Revenue Account (399.000.4750) and transfer \$242,280 into the Grant Machinery and Equipment expense account (399.131.5910); \$80,000 in the Grant Vehicles expense account (399-131-5920), \$25,400 into the Grant Conferences expense account (399-131-5750), and \$30,500 into the Grant Travel expense account (399.131.5910).

**Section 2.** The City of Conway hereby approves waiving the competitive bid requirement and will utilize TWB Designs as a sole source vendor for the ammo burner upgrade (\$30,000).


**Section 3.** All ordinances in conflict herewith are repealed to the extent of the conflict.

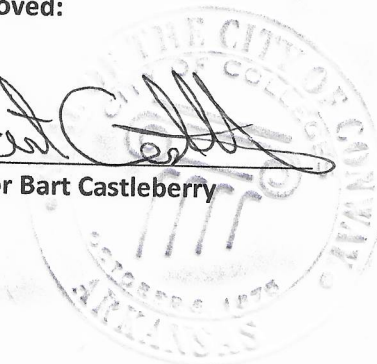
