**City of Conway, Arkansas  
Ordinance No. O-24-24**

**AN ORDINANCE APPROPRIATING FUNDS FOR A FINANCE AGREEMENT MADE IN 2022 FOR THE PURCHASE OF ONE RESCUE PUMPER UNIT AND ONE PUMPER UNIT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES**

**Whereas** Conway City Council previously approved the purchase of one rescue pumper unit and one pumper unit through O-22-108, and;

**Whereas**, The Conway Fire Department is responsible for yearly payments. \$250,000 is funded by pay as you go, the remainder of \$128,525 is due from the general fund and was not included in the 2024 budget, as previously approved.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**

**Section 1.** The City of Conway shall appropriate \$128,525 from the General Fund Balance Appropriation account 001.119.4900 into the Fire Department Vehicles Account 001.131.5920.

**Section 2.** This ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effort from and after its passage and approval.

**Section 3.** All ordinances in conflict herewith are repealed to that extent of the conflict.
