**City of Conway, Arkansas
Ordinance No. O-24-29**

AN ORDINANCE TO WAIVE THE COMPETITIVE BID PROCESS FOR THE PURCHASE OF (2) TWO NEW VEHICLES FOR THE CONWAY POLICE DEPARTMENT; DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

Whereas, the Conway Police Department needs to purchase two (2) 2024 Chevrolet Tahoe Police Pursuit vehicles; and

Whereas, Superior Automotive Group is currently the only manufacturer who can supply these Police Pursuit vehicles within the state; therefore, we are requesting City Council waive the bid process and approve the purchase of two (2) vehicles in the amount of \$104,334.00; and

Whereas, funding for these vehicles was included in the FY2024 budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall waive competitive bid requirements for two (2) Chevrolet Tahoe's and enter into an agreement to purchase two Chevrolet Tahoe's from Superior Automotive Group in the amount of \$104,334.

Section 2. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 3. This ordinance is necessary for the protection of the public peace, health, and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

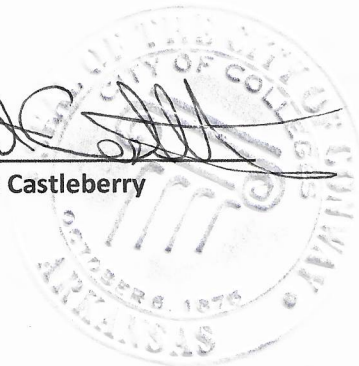
