ORDINANCE

City of Conway, Arkansas
Ordinance No. O-25-22

AN ORDINANCE TO APPROPRIATE FUNDING AND APPROVE THE PURCHASE OF (5) FIVE NEW VEHICLES FOR THE CONWAY POLICE DEPARTMENT; DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

Whereas, the Conway Police Department needs to purchase five (5) 2024 Chevrolet Tahoe Police Pursuit vehicles; and

Whereas, the purchase of five (5) vehicles will be from Bale Chevrolet vehicles in the amount of \$500,000; and

Whereas, funding for these vehicles will come from Pay as you go.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall purchase (5) Chevrolet Tahoe's and enter into an agreement with Bale Chevrolet in the amount of \$500,000.

Section 2. The City of Conway shall appropriate pay as you go funds from the Fund Balance Appropriation Account (613-201-4900) to the Conway Police Department vehicles account (613-121-5920).

Section 3. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 4. This ordinance is necessary for the protection of the public peace, health, and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.


