ORDINANCE

AN ORDINANCE APPROPRIATING REIMBURSEMENT FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

Whereas, the City of Conway has received reimbursements funds from the following entities:

Various Companies	\$28,638.85	Extra Duty Services
Municipal Vehicle Program	\$12,642.60	Insurance Proceeds
Various Companies	\$250.00	Donations
BVP	\$18,529.56	Reimbursement

Whereas, the Conway Police Department needs these funds to replenish their expenditure accounts.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funds from Various Companies in the amount of \$28,638.85 from 001.121.4185 to the CPD overtime expense account, 001.121.5114.

Section 2. The City of Conway shall appropriate funds from the Municipal Vehicle Program in the amount of \$12,642.60 from 001.119.4360 to the CPD vehicle maintenance expense account 001.121.5450.

Section 3. The City of Conway shall appropriate funds from Various Companies in the amount of \$250.00 from 001.121.4705 to the CPD grant and donation expense account 001.121.5760.

Section 4. The City of Conway shall amend the 2025 budget and appropriate funds from the Patrick Leahy Bulletproof Vest Partnership in the amount of \$18,529.56 from 001.119.4900 to the Police Department Accountable Equipment expense account 001.121.5650.

Section 5. All ordinances in conflict herewith are repealed to the extent of the conflict.
