ORDINANCE

AN ORDINANCE ACCEPTING THE REQUEST FOR PROPOSALS FOR SEVERAL ARTISTS FOR ART & MURAL PROJECTS AND APPROPRIATING FUNDING FOR THE CITY OF CONWAY & PUBLIC ART ADVISORY COMMITTEE; AND FOR OTHER PURPOSES:

Whereas, the City of Conway solicited art qualifications in February, 2025 from artists who provide original artwork/murals to be displayed in prominent locations around the City of Conway, and

Whereas, the qualifications were open to the public and stated that multiple artists could be chosen to perform different projects throughout the City of Conway, including projects commissioned by the Conway Public Art Advisory Committee; and

Whereas, five artists were selected to be placed on an on-call service list to perform projects as they arise for the City of Conway and the Public Art Advisory Committee with annual renewal; and

Whereas, funding will come for the Parks & Recreation Voluntary Tax Fund designated for public art projects.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall accept the proposals from the following artists and use each artist as on-call services for different art projects throughout the City of Conway on an annual renewal basis.

Section 2. The City of Conway shall appropriate \$50,000 for various art projects and miscellaneous art expenses from the Parks & Recreation Voluntary Property Tax Fund Balance Appropriation Account (221.140.4900) to the Parks & Recreation – CIP Misc. Account (221.140.5990).

Section 3. All resolutions in conflict herewith are repealed to the extent of the conflict.
