

RESOLUTION NO. R-80- 16

A RESOLUTION EXPRESSING THE WILLINGNESS OF THE CITY OF CONWAY TO MATCH STATE AID CITY STREET FUNDS FOR THE SPENCER STREET, FRONT STREET, FIRST STREET, TYLER STREET, LEIGH STREET, MORNINGSIDE DRIVE, OAKDALE, REDBUD AND SALEM ROAD PROJECTS.

WHEREAS, the City of Conway understands State Aid City Street funds are available for improvements to the city streets; and

WHEREAS, the City has determined that the top priority project is Spencer, Front, First, Tyler, Leigh Streets, Morningside Drive, Oakdale, Redbud, and Salem Road; and

WHEREAS, the City will be responsible for all costs above the amount available in the State Aid Street Fund (a minimum 30% city funds).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

Section 1. The City of Conway will participate in accordance with its designated responsibility in this project.

Section 2. The City of Conway pledges its full support and hereby authorizes and requests the Arkansas State Highway and Transportation Department to initiate action to construct this project.

Section 3. The Mayor is hereby authorized and directed to execute all appropriate agreements and contracts necessary to expedite the construction of the improvements on city streets.

AGREEMENT OF UNDERSTANDING  
BETWEEN  
THE CITY OF Conway, ARKANSAS  
AND  
THE ARKANSAS HIGHWAY AND  
TRANSPORTATION DEPARTMENT

RELATIVE TO

The improvement of city streets to be constructed under the State Aid City Street Program.

WHEREAS, Act 982 of the 1975 General Assembly of the State of Arkansas provides 70% State Aid City Street funds to be matched with a minimum of 30% local funds for improvements to facilities on the State Aid City Street System, and

WHEREAS, the City has expressed its desire to participate in the State Aid City Street Program,

IT IS HEREBY AGREED that the City of Conway and the Arkansas Highway and Transportation Department will participate in a cooperative program for street construction, and

HEREBY, accept the responsibilities and assigned duties as described hereafter.

THE CITY WILL:

1. Be responsible for all costs above the amount of funds available in the State Aid Street fund.
2. Make no alterations to the improvements constructed under the State Aid City Street Program without first consulting with the Arkansas Highway and Transportation Department.
3. Be responsible for satisfactory maintenance and operation of all improvements on that portion of the State Aid City Street System not on the Arkansas Highway System and all traffic signals on the Arkansas Highway System. Failure to adequately maintain and operate the facility in accordance with State requirements will result in withholding future State Aid City Street funds.
4. Be responsible for the necessary enforcement of operations as required by improvements on the Arkansas State Highway System and the State Aid City Street System.
