

RESOLUTION NO. R-86-06

A RESOLUTION REFERRING ORDINANCE NO. 0-86-21
OF THE CITY OF CONWAY, ARKANSAS TO THE
ELECTORS PURSUANT TO ARK. STAT. ANN. SECTION
19-2429.

BE IT RESOLVED by the City Council of the City of
Conway, Arkansas:

Section 1. That Ordinance No. 0-86-21 of the City of
Conway, Arkansas, which authorizes the issuance of \$4,500,000 of
Water Revenue Bonds, Series 1986, is hereby referred to the
electors of the City of Conway at a special election, which is
hereby called and shall be held on April 15, 1986.

Section 2. That the question of acceptance or
rejection of Ordinance No. 0-86-21 shall be placed on the ballot
for the election in substantially the following form:

VOTE on measure by placing an "X" in the square
opposite the measure either FOR or AGAINST:

FOR Ordinance No. 0-86-21 and the issuance of
\$4,500,000 of City of Conway, Arkansas Water
Revenue Bonds, Series 1986, as provided for
in said Ordinance

AGAINST Ordinance No. 0-86-21 and the issuance
of \$4,500,000 of City of Conway, Arkansas Water
Revenue Bonds, Series 1986, as provided for
in said Ordinance

Section 3. That the election shall be held and
conducted and the vote canvassed and the results declared under
the law and in the manner now provided for municipal elections
and only qualified voters of the City shall have the right to
vote at the election.

Section 4. That a copy of this Ordinance shall be
given to the Faulkner County Board of Election Commissioners so
that the necessary election officials and supplies may be
provided.

Section 5. That the Mayor and City Clerk, for and on
behalf of the City, are hereby authorized and directed to do any
and all things necessary to cause the election to be called and
held as herein provided.

Section 6. That all resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.


