RESOLUTION

BE IT RESOLVED, by the City Council of the City of Conway, Arkansas, that WHEREAS, the City Council of the City of Conway, Arkansas, has been informed that Kevin Smith and Kim Smith have petitioned or will petition the County Court of Faulkner County, Arkansas, for annexation into the City of Conway, Arkansas, of the following described lands in Faulkner County, Arkansas:

Tract 1: Part of the SE 1/4 SE 1/4, Section 8, Township 5 North, Range 13 West, described as beginning at the southwest corner of said SE 1/4 SE 1/4, and run thence along the west line of said SE 1/4 SE 1/4, north 0 degrees 36 minutes 19 seconds west 661.79 feet; thence south 89 degrees 42 minutes 47 seconds east 329.10 feet; thence south 0 degrees 36 minutes 19 seconds east 661.79 feet to the south line of said SE 1/4 SE 1/4; thence along said south line north 89 degrees 42 minutes 47 seconds west 329.10 feet to the point of beginning, containing 5.0 acres, more or less.

Tract 2: Part of the SE 1/4 SE 1/4 of Section 8, Township 5 North, Range 13 West, described as beginning at the southwest corner of said SE 1/4 SE 1/4; thence along the west line of said SE 1/4 SE 1/4 north 0 degrees 36 minutes 19 seconds west 661.79 feet to the point of beginning; thence continuing north 0 degrees 36 minutes 19 seconds west 661.79 feet to the northwest corner of said SE 1/4 SE 1/4; thence along the north line of said SE 1/4 SE 1/4 south 89 degrees 09 minutes 37 seconds east 658.60 feet to the northeast corner of the W 1/2 SE 1/4 SE 1/4; thence along the east line of said W 1/2 SE 1/4 SE 1/4 south 01 degree 16 minutes 38 seconds east 1,317.56 feet to the southeast corner of said W 1/2 SE 1/4 SE 1/4; thence along the south line of said W 1/2 SE 1/4 SE 1/4 north 89 degrees 42 minutes 47 second west 344.83 feet; thence north 0 degrees 36 minutes 19 seconds west 661.79 feet; thence north 89 degrees 42 minutes 47 seconds west 329.10 feet to the point of beginning, containing 15.19 acres, more or less.

WHEREAS, it is desired to indicate unto the County Court of Faulkner County, Arkansas, the attitude of the City of Conway, Arkansas, toward such annexation.

NOW, BE IT RESOLVED by the City Council of the City of Conway, Arkansas, that said City Council does hereby declare its willingness to accept said lands as a part of the City of Conway, Arkansas, provided said County Court of Faulkner

County, Arkansas, shall, in the exercise of its discretion, deem said lands suitable for annexing unto the City of Conway, Arkansas.
