WHEREAS, there exist two "islands" of county land completely surrounded by the municipality of Conway; and

WHEREAS, one is located on both sides of Interstate 40, east of the airport, west of Stonebridge Subdivision, and south of Highway 64 East and is approximately 221.36 acres in area, and the other is located south of Middle Road and is approximately 3 acres in area; and

WHEREAS, they comply with the standards for land qualifying for annexation which are set forth in Arkansas Stat. Ann. 19-307.1 and Act 314 of 1979.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

That this resolution shall establish the intent to annex the above noted properties which are described in Exhibit A which is attached hereto and incorporated by reference on an after the completion of all legal requirements regarding annexation of lands completely surrounded by a municipality.
