

RESOLUTION R-90-05

BE IT RESOLVED, by the City Council of the City of Conway, Arkansas, that WHEREAS, the City Council of the City of Conway, Arkansas, has been informed that Danny Joe Eades and Marian Kordsmeier Eades have petitioned or will petition the County Court of Faulkner County, Arkansas, for annexation into the City of Conway, Arkansas, of the following described lands in Faulkner County, Arkansas:

A part of the West 1/2 SE 1/4, Section 20, T5N, R13W, described as beginning at a point 210 feet south 00 degrees 03 minutes east of the northeast corner of said West 1/2 SE 1/4; thence west 228.56 feet; thence south 00 degrees 03 minutes 40 seconds east 210 feet; thence east 228.52 feet to the east line of said West 1/2 SE 1/4; thence north 00 degrees 03 minutes west 210 feet along said east line to the point of beginning, containing 1.10 acres, more or less, subject to a 25-foot road easement on the west side.


Also, a part of the West 1/2 SE 1/4, Section 20, T5N, R13W, described as beginning at the northeast corner of said West 1/2 SE 1/4, run thence west 228.6 feet; thence south 00 degrees 03 minutes 40 seconds east 210 feet; thence east 228.56 feet to the east line of said West 1/2 SE 1/4; thence north 00 degrees 03 minutes west 210 feet along said east line to the point of beginning, containing 1.10 acres, more or less, subject to county road easement along the north side and containing a 25-foot road easement along the west side.

WHEREAS, it is desired to indicate unto the County Court of Faulkner County, Arkansas, the attitude of the City of Conway, Arkansas, toward such annexation.

NOW, BE IT RESOLVED by the City Council of the City of Conway, Arkansas, that said City Council does hereby declare its willingness to accept said lands as a part of the City of Conway, Arkansas, provided said County Court of Faulkner County, Arkansas, shall, in the exercise of its discretion, deem said lands suitable for annexing unto the City of Conway, Arkansas.


