R E S O L U T I O N

BE IT RESOLVED, by the City Council of the City of Conway, Arkansas, that WHEREAS, the City Council of the City of Conway, Arkansas, has been informed that James D. Clements, Janetta L. Clements and others have petitioned or will petition the County Court of Faulkner County, Arkansas, for annexation into the City of Conway, Arkansas, of the following described lands in Faulkner County, Arkansas:


Part NE 1/4 of Section 9, Township 5 North, Range 14 West, described as beginning at the southeast corner of the S 1/4 NE 1/4 NE 1/4 and run north to the northeast corner of the S 1/4 NE 1/4 NE 1/4 of said Section 9; thence continue north along the east line of the NE 1/4 NE 1/4 a distance of 230 feet; thence west 209 feet; thence south 20 feet; thence west 20 feet; thence south 210 feet; thence west 1,091 feet, more or less, to the west line of the NE 1/4 NE 1/4; thence north to the south right-of-way of Highway #60; thence southwestwardly along said right-of-way a distance of 190.5 feet; thence south 2,206.6 feet to the south line of the SW 1/4 NE 1/4 of Section 9; thence east along the south line of said SW 1/4 NE 1/4 a distance of 155 feet to the southeast corner of said SW 1/4 NE 1/4; thence continue along the south line of the SE 1/4 NE 1/4 to the southeast corner of the West 1/2 SE 1/4 NE 1/4; thence north along the east line of the West 1/2 SE 1/4 NE 1/4 a distance of 1,320 feet to the south line of the NE 1/4 NE 1/4; thence east to the point of beginning, containing in the aggregate 38.82 acres, more or less.

WHEREAS, it is desired to indicate unto the County Court of Faulkner County, Arkansas, the attitude of the City of Conway, Arkansas, toward such annexation.

NOW, BE IT RESOLVED by the City Council of the City of Conway, Arkansas, that said City Council does hereby declare its willingness to accept said lands as a part of the City of Conway, Arkansas, provided said County Court of Faulkner County, Arkansas, shall, in the exercise of its discretion, deem said lands suitable for annexing unto the City of Conway, Arkansas.

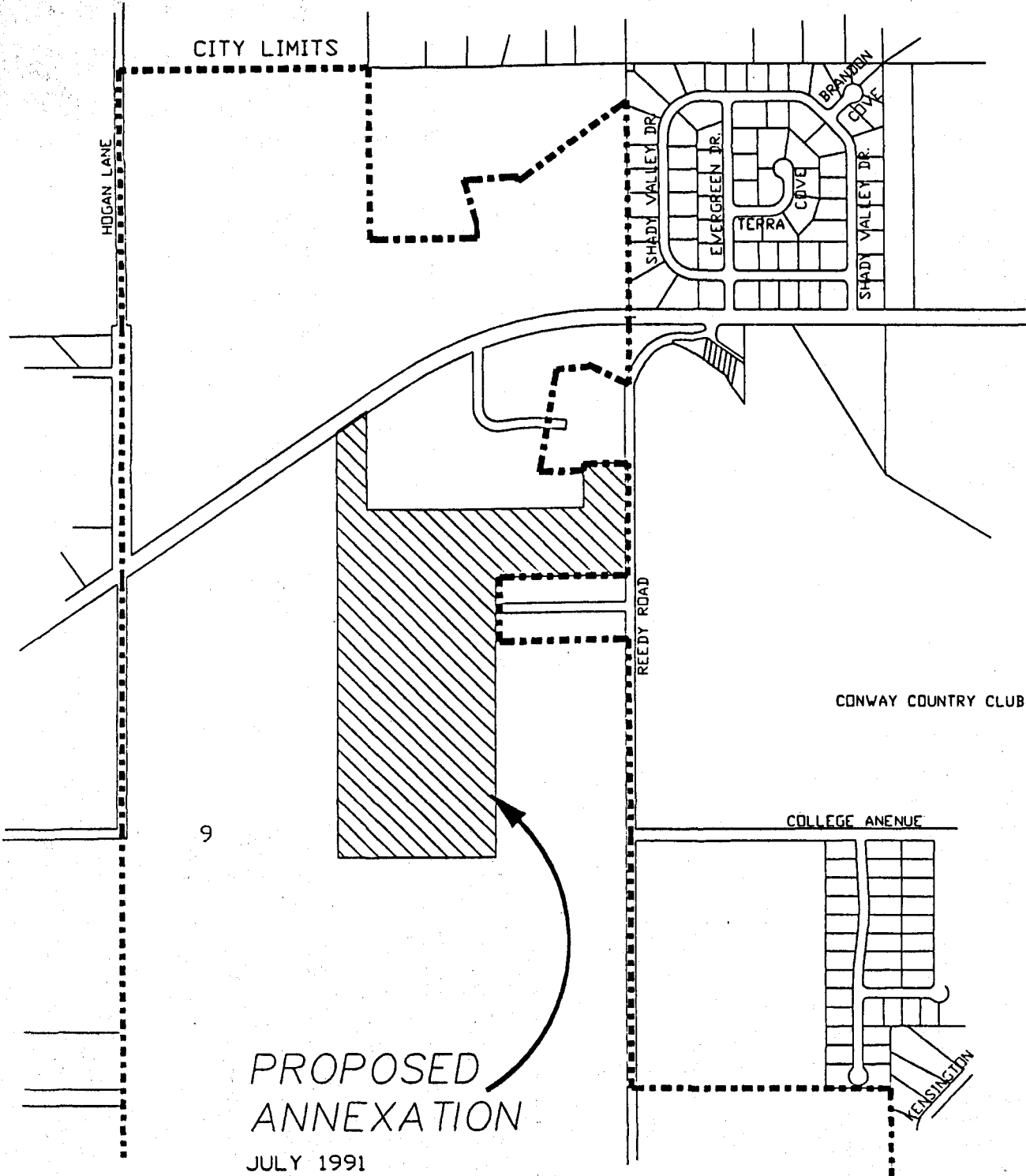

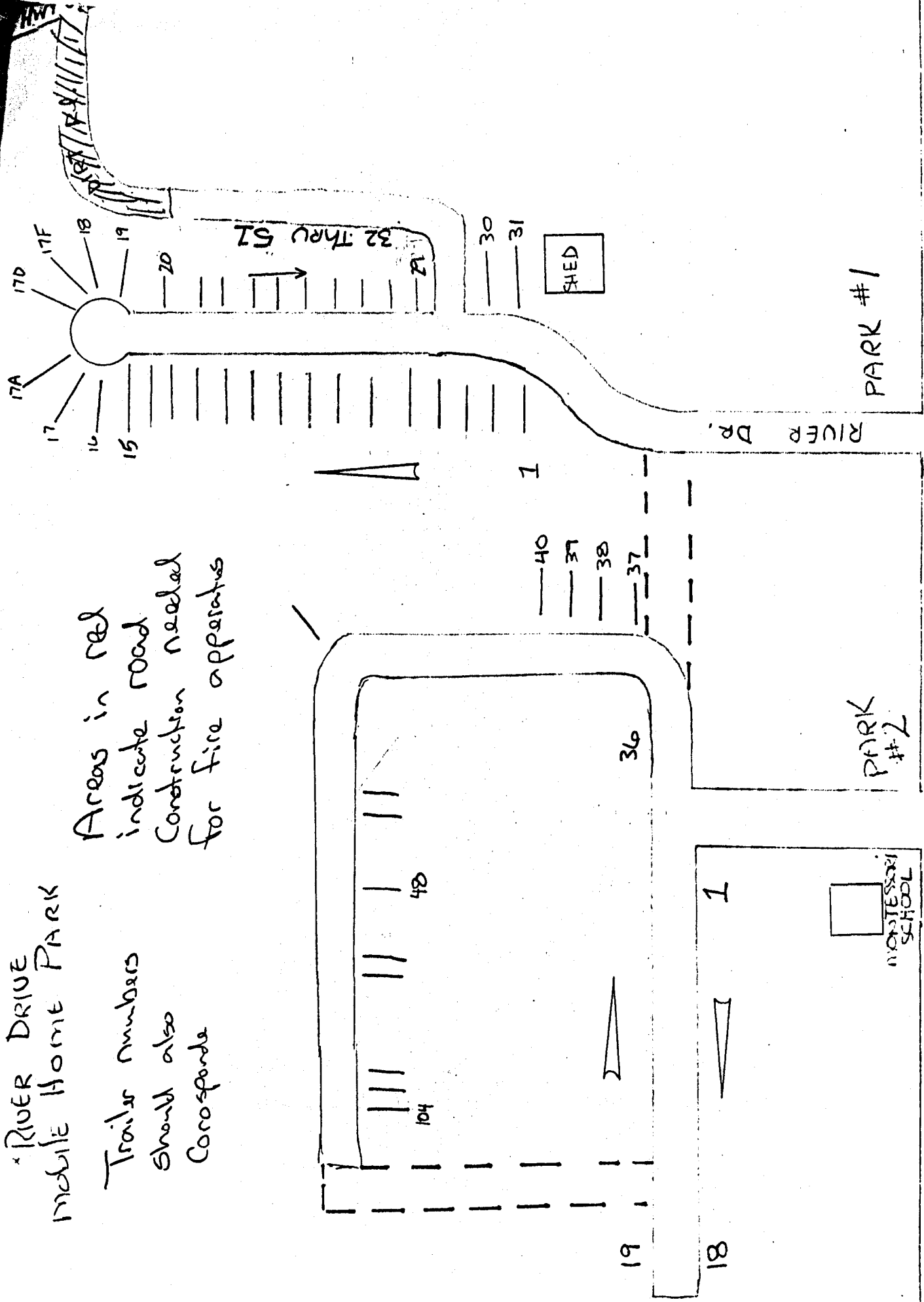
