### AN ORDINANCE CLOSING A PORTION OF THE 20 FOOT UTILITY AND DRAINAGE EASEMENT ON LOT 17, PRINCETON VILLAGE PUD; AND FOR OTHER PURPOSES:

**Whereas**, a petition was duly filed with the City of Conway, Arkansas on the 12<sup>th</sup> of January, 2017 by Keller Johnson asking the City Council to vacate and abandon the southern 10 feet of the 20 foot utility and drainage easement on Lot 17, Princeton Village PUD.

Whereas, after due notice as required by law, the council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the easement or the portion thereof, hereinbefore described, has heretofore been dedicated to the public use as a utility and drainage easement herein described; has not been actually used by the public generally for a period of at least five (5) years subsequent to the filing of the plat; that all the owners of the property abutting upon the portion of the easement to be vacated have been afforded the opportunity to file with the council their written consent to the abandonment; and the public interest and welfare will not be adversely affected by the abandonment of this portion of the easement.

#### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY ARKANSAS:

**Section 1.** The City of Conway, Arkansas releases, vacates, and abandons its rights, together with the rights of the public generally, in and to the easement designated as follows:

The southern 10 feet of the 20 foot, utility and drainage easement on Lot 17, Princeton Village PUD

**Section 2.** A copy of the ordinance duly certified by the city clerk shall be filed in the office of the recorder of the county and recorded in the deed records of the county.

Re: Siebenmorgen Half Road Improvement

Change Order #2

A change order is needed for adjusting three (3) Sewer Man Holes impacting sidewalk elevations on the Siebenmorgen Half Road Improvement project. These manhole adjustments were not accounted for in the bid spec, thus needs to be added to accommodate the new elevations on site. Two manholes require raising 24" which exceeds the length allowed for ring extensions, and one needs to be lowered approximately 14". Attached is a change order request from the contractor in the amount of \$6,300. We are requesting approval of this in order to complete the sidewalk improvements and finish the job.

The original project budget was estimated at \$400,000. The initial contract came in at \$361,272. Incorporating the first change order of \$9,810 for an additional culvert and this change order will bring the contract to \$377,382. This represents a 4% increase in contract price.

#### **Master Street Plan Amendment**

The Planning Department in coordination with the Engineering Department is requesting that the City Council review and approve the enclosed Master Street Plan amendment.

This Master Street Plan amendment will remove the proposed collector street right of way shown connecting Salem Road to Miller's View Road. The proposed right of way was placed on the Master Street Plan in July 2008 as part of the Old Morrilton Highway Small Area Plan. The right of way placement is problematic as the proposed right of way would need to cross Union Pacific property (the Cadron Ridge tunnel).

### Re: Conditional Use Permit request to allow a nursing/assisted living facility on property located at 2505 Salem Road

Mt. Carmel Community, LLC has requested a Conditional Use Permit to allow a Class A, luxury senior living community, including 46 independent living garden homes and a 75-unit assisted living center, on property zoned A-1 (Agricultural), located at 2505 Salem Road [address to be assigned via plat] with the legal description:

Part of the NW1/4 SW1/4, Section 35, T-6-N, R-14-W, Faulkner County, Arkansas, more particularly described as follows: Commencing at the NE corner of said NW1/4 SW1/4 and run S01°38'10"W along the east side of said NW1/4 SW1/4, 463.47' to the point of beginning; thence continue S01°38'10"W along the west right of way of Salem Road, 9.27' to the P.C. of a curve to the right, having a radius of 914.0'; thence along said curve too a point S36°58'58"W, 817.29'; being the P.T. of said curve; thence S63°30'24"W along said right of way, 242.19'; thence S70°06'28"W, along said right of way, 171.84'; thence leaving said right of way, N80°44'00"W, 155.0'; thence N60°32'30"W, 360.07' to a point on the west line of said NW1/4 SW1/4, said point being 188.50' N01°36'15"E of the SW corner of said NW1/4 SW1/4; thence N01°36'15"E along said west line, 664.88'; thence S88°21'36"E parallel with the north line of said NW1/4 SW1/4, 1318.31' to the point of beginning. Containing 20.00 +/- acres subject to any easements which may be located thereon.

was reviewed by the Planning Commission at its regular meeting on January 17, 2017. The Planning Commission voted 9-1, with Jerry Rye voting in opposition, that this request be forwarded to the City Council with a recommendation for approval with the following conditions:

- 1. Right-of-way dedication at the Salem Road/Meadowlake Road intersection for a roundabout per City Engineer specifications shall be dedicated during platting/development review.
- 2. The proposed development shall be generally constructed as presented.
- 3. Single ownership of all property and structures is required.
- 4. Right of way from roundabout to access residual Irby property to the south and west per City Engineer specifications shall be dedicated during platting and development review.

# A RESOLUTION EXPRESSING THE WILLINGNESS OF THE CITY OF CONWAY TO ACCEPT PORTIONS OF THE INTERSTATE 40 FRONTAGE ROAD SYSTEM INTO THE CITY STREET SYSTEM FROM THE ARKANSAS STATE HIGHWAY AND TRANSPORATION DEPARTMENT:

Whereas, the City of Conway (the City) has requested the Arkansas State Highway and Transportation Department (the Department) to transfer a portion of the Interstate 40 Frontage Road System, locally known as North Amity Road, to the City Street System to provide expedient development, access management, and permitting; and

Whereas, the City and the Department agree that it is in the best interest of all parties to transfer ownership and associated maintenance responsibility of the portion of the Interstate 40 Frontage Road to the City Street System from approximately 700 feet north of the intersection with Arkansas State Highway 286 (Dave Ward Drive) near the extents of construction of AHTD Job# 080492 to the existing end of state maintenance; and

**Whereas,** the City understands the Department will retain control of access to the commuter park and ride lot adjacent to the Interstate 40 Frontage Road in the northwest quadrant of the intersection with Arkansas State Highway 286 (Dave Ward Drive).

### NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

**Section 1.** The City will assume ownership and associated management and maintenance of North Amity Road as specified above.

**Section 2.** The Mayor of the City of Conway is hereby authorized and directed to assume ownership of the above stated right-of-way.

**Section 3.** The City of Conway pledges its full support and hereby authorizes the Arkansas State Highway and Transportation Department to initiate action to implement this agreement.
