A RESOLUTION AUTHORIZING CONWAY CORPORATION TO ACT PURSUANT TO ARK. CODE ANN. § 18-15-301 ET SEQ., ARK. CODE ANN. § 18-15-401 ET SEQ, ARK. CODE ANN. § 18-15-501 ET SEQ. AND OTHER STATE STATUTORY AUTHORITY TO SEEK CONDEMNATION BY EMINENT DOMAIN PROCEEDINGS OF CERTAIN PROPERTIES DESCRIBED HEREIN FOR THE PUBLIC PURPOSES OF CONSTRUCTING A WATER TREATMENT FACILITY AND A DUAL VOLTAGE SUBSTATION.

**Whereas**, the City of Conway, Arkansas, is a city of the First Class duly organized and existing as a municipal corporation under the laws of the State of Arkansas. The City of Conway ("the City") has its principal place of business within the borders of Faulkner County, Arkansas; and

Whereas, Conway Corporation is an Arkansas non-profit corporation with its principal place of business located in Conway, Faulkner County, Arkansas. Conway Corporation is the franchisee of the City of Conway for the purposes of maintaining and operating the City's water and electric utilities; and

**Wherea**, the primary source of drinking water for the City of Conway is Brewer Lake, a manmade lake of approximately One Thousand One Hundred (1,100) acres located north of Plumerville, Arkansas. Water from Brewer Lake is carried through underground pipes across Conway County and Faulkner County, Arkansas, to water treatment facilities operated by Conway Corporation in or near the City of Conway, and then to the citizens and businesses of the City of Conway through the City's water distribution system, and

Whereas, it is necessary and in the public interest to construct an additional water treatment facility and electric substation to serve the need of the residents of the City in the eastern part of the City; and

Whereas the water treatment facility will carry water from Greers Ferry Lake to the City in order to meet the growing needs of the City of Conway; and

Whereas in order to properly complete the aforementioned project, it is necessary to acquire the following described lands (hereinafter referred to as the "Real Property"):

A PART OF THE NW1/4 OF SECTION 10, TOWNSHIP 5 NORTH, RANGE 13 WEST, FAULKNER COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS COMMENCING AT THE NORTHWEST CORNER OF SAID NW1/4 AND RUNNING THENCE S01°30'27"W ALONG THE WEST LINE OF SAID NW1/4 325.6 FEET TO THE POINT OF BEGINNING; THENCE RUN S83°11'42"E, 1750.57 FEET TO A 1/2" REBAR WITH CAP (1363); THENCE RUN S01°44'45"W, 219.74 FEET TO A 1/2" REBAR WITH CAP (1363); THENCE RUN S01°44'45"W, 219.74 FEET TO A CHAIR LEG; THENCE RUN S69°55'19"E, 228.75 FEET TO A 1/2" REBAR WITH CAP (1363) ON THE EAST LINE OF THE W1/2 E1/2 OF SAID NW1/4; THENCE RUN S01°22'55"W, 1917.98 FEET TO THE SOUTHEAST CORNER OF SAID W1/2 E1/2 NW1/4; THENCE RUN N87°22'41"W, 642.77 FEET TO THE SOUTHEAST CORNER OF THE SW1/4 OF SAID NW1/4; THENCE RUN N87°21'33"W, 1320.84 FEET TO THE SOUTHWEST CORNER OF SAID NW1/4; THENCE RUN N01°30'27"E, ALONG THE WEST LINE OF SAID NW1/4 100.02 FEET; THENCE RUN S87°21'33"E PARALLEL TO THE SOUTH LINE OF SAID SW1/4 NW1/4, 323.74 FEET; THENCE RUN N64°22'28"E, 382.51 FEET; THENCE RUN N64°15'03"E, 203.55 FEET; THENCE RUN N01°30'27"E, 869.65 FEET; THENCE RUN N87°21'33"W, 845.21 FEET TO THE WEST LINE OF SAID NW1/4; THENCE RUN N01°30'27"E, 1085.91 FEET TO THE POINT OF BEGINNING CONTAINING 80.00 ACRES MORE OR LESS.

**Whereas** to secure timely access to said Real Property, however, it is necessary that eminent domain authority be declared, established, and exercised for the purpose of the construction, maintenance, and public uses specified above. As well, and on behalf of the public, the City must continue ownership and control of the Real Property described herein.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

**Section 1**: The City Council hereby finds and determines that it is necessary for public purposes to acquire the Real Property described herein upon which to construct and maintain said water treatment facility and electric substation. Being unable to reach an agreement and compromise as to the amount of just compensation to pay the respective landowners, it is necessary for public purposes to acquire the Real Property owned by the landowners described herein upon which to construct and maintain said water treatment facility and electric substation. The Real Property is owned by multiple landowners one of which is deceased with no estate having been opened, and there is no personal representative to obtain a Court order and sign a real estate contract to sale the decedent's interest in the Real Property. Because the City has established a legitimate public purpose for said Real Property, the City of Conway and Conway Corporation are empowered under Ark. Code Ann. § 18-15-301 *et seq.*, § 18-15-401 *et seq.* and § 18-15-501 *et seq.* to seek condemnation through eminent domain of the properties described herein and to properly compensate the owners of said properties pursuant to state law.

**Section 2:** Conway Corporation is hereby authorized, on behalf of the City, to initiate statutory proceedings for eminent domain and condemnation of the Real Property described herein for the purposes stated herein, up to and including filing appropriate legal pleadings and process in those courts of law having jurisdiction over such process and proceedings.

# A RESOLUTION GRANTING A LICENSE TO BLUE SKY TRANSPORTATION TO OPERATE A TAXI SERVICE WITHIN THE CITY OF CONWAY; AND FOR OTHER PURPOSES,

Whereas the City of Conway recognizes the importance of accessible and reliable transportation options for residents, businesses, and visitors, ensuring that all individuals have the ability to travel within the city efficiently and safely; and

**Whereas**, Blue Sky Transportation will provide essential services to the community, supporting the city's growing transportation needs, and offering an alternative to existing transportation services; and

Whereas, Blue Sky Transportation has met all necessary regulatory and operational requirements set forth by the city; and

**Whereas**, all applicable fees and insurance verification have been provided and approved by the City Clerk/Treasurer's Office.



It is the intent of the applicant to rezone this parcel to S-1 for a daycare for children under the age of 2 for Conway Christian staff. S-1 zones are required to be a minimum of 1 acre. Platting this parcel in with the school campus fulfills that requirement and legitimizes the requested use. The site is currently unplatted and will have to undergo light site development review due to the change of residential use to non-residential. The property will need to be platted alongside the Conway Christian campus prior to the issuance of a certificate of occupancy. New addresses will be assigned at the time of site development and subdivision review.

The Planning Commission reviewed the request at its regular meeting on June 16, 2025, and voted 8-0 that the request be forwarded to the City Council with a recommendation for approval.

AN ORDINANCE AUTHORIZING THE ISSUANCE OF A PROMISSORY NOTE TO PROVIDE SHORT-TERM FINANCING UNDER AMENDMENT NO. 78 TO THE ARKANSAS CONSTITUTION FOR CERTAIN EQUIPMENT PURCHASES (MID-MOUNT AERIAL APPARATUS) FOR THE CONWAY FIRE DEPARTMENT AND TO UPGRADE THE P25 PUBLIC SAFETY RADIO SYSTEM NETWORK AND CORE FOR THE CONWAY EMERGENCY OPERATIONS CENTER; PROVIDING FOR PAYMENT OF THE PRINCIPAL AND THE INTEREST ON THE NOTE; APPROPRIATING FUNDS FROM GENERAL REVENUES; REIMBURSING THE CITY FOR PREVIOUS COSTS INCURRED PURCHASING CERTAIN ITEMS; REPEALING ANY OTHER ORDINANCES IN CONFLICT HEREWITH; DECLARING AN EMERGENCY AND PRESCRIBING OTHER MATTERS PERTAINING THERETO.

Whereas, the City of Conway, Arkansas (the "City") is authorized and empowered under the provisions of Amendment No. 78 to the Arkansas Constitution ("Amendment No. 78") and Act No. 1808 of 2001 (codified as Arkansas Code Annotated § 14-78-101, *et seq.*, the "Act"), to incur short term financing obligations maturing over a period of, or having a term not to exceed five (5) years for the purpose of acquiring, constructing, installing and renting real property or tangible personal property having an expected useful life of more than one year; and

Whereas, it is proposed that the City issue its Promissory Note in the principal amount up to \$4,000,000 (the "Note") under Amendment No. 78 and the Act for the purpose of providing financing for all or a portion of the cost for certain equipment purchases (Mid-mount aerial apparatus for the City of Conway Fire Department & P25 Public Safety Radio System Network and Core (the "Project"); and

Whereas, the City may expended from its General Fund and it is proposed that the City reimburse said Fund a portion of the specific costs incurred for certain equipment purchases prior to the date of the proposed Promissory Note; and

**Whereas**, the City intends to arrange for the loan (the "Loan") from a financial institution (the "Lender") and to issue the Note to the Lender at a price of par in consideration for the Loan.

# NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

**Section 1**: The City of Conway City Council (the "City Council") hereby finds that the Project is real or tangible personal property having a useful life of more than one year. The City Council further finds that the sum of the principal amount of the proposed Promissory Note and the outstanding principal amount of the City's other promissory notes issued under the authority of Amendment 78 do not exceed five percent (5%) of the assessed value of taxable property located within the City as determined by the last tax assessment completed before the issuance of the proposed Promissory Note.

Section 2: Under the authority of the Constitution and laws of the State of Arkansas, including particularly Amendment No. 78 and the Act, the issuance of the Promissory Note in the principal amount of up to \$4,000,000 is hereby authorized for the purpose of financing a portion of the cost of the Project. The Note shall be dated the date of its issuance and shall bear interest on the outstanding principal amount at a fixed rate of 3.87% per annum (calculated on the basis of the actual number of days elapsed in a year of 365 days (366 days in a leap year). The Note shall be repaid within five years from the first draw thereunder, and the Note shall commence to bear interest as of such date as contemplated by Arkansas Code Annotated § 14-78-102(4). The Note shall be issued in fully registered form.

**Section 3:** To the extent permitted by U. S. Treasury Regulation 1.150-2 (the "Regulation) the City may reimburse its General Fund a portion of the specific costs incurred for certain equipment purchases associated with this Project from the proceeds of the Note.

Section 4: First Service Bank has been selected by the Mayor, and approved by the City Council, based upon the commitment or proposal for the Loan that the Mayor has determined to have the lowest cost to the City after soliciting proposals or commitments for the Loan and receiving such proposals and commitments on May 15<sup>th</sup>, 2025 from at least three financial institutions having offices in Faulkner County.

Section 5: It is expected that the first draw on the borrowings will occur on or about <u>July 1<sup>st</sup>, 2025</u> and the City will execute the Note immediately prior to such draw. Interest will begin to accrue on only the amount borrowed as of the date of each draw.

**Section 6:** As provided in Amendment No. 78, the debt service payments on the Note shall be charged against and paid from the general revenue of the City within five years, but not later than five (5) years from the date of the first draw on the Note when the obligation commences to bear interest, as contemplated by Arkansas Code Annotated § 14-78-102(4). For the purpose of making the annual debt service, there is hereby, and shall be, appropriated to pay the Note, an amount of general revenue of the City sufficient for such purposes. The City's Director of Finance is hereby authorized and directed to withdraw from the general revenues of the City the amounts at the times necessary to make the annual debt service payments on the Note.

Section 7: The Mayor and City Clerk, for and on the behalf of the City, are hereby authorized and directed to do any and all things necessary to effect the issuance execution, and delivery of the Note, and the performance of all acts of whatever nature necessary to effect and carry out the authority conferred by this Ordinance. The Mayor and City Clerk are hereby further authorized and directed, for and on behalf of the City, and to execute all papers, documents, certificates, and other instruments that may be required for the carrying out of such authority or to evidence the exercise thereof. The City covenants that it shall not take any action or suffer or permit any action to be taken or conditions to exist which causes or may cause the interest payable on the Note to be included in gross income for federal income tax purposes. Without limiting the generality of the foregoing, the City covenants that the proceeds of the Note will not be used directly or indirectly in such manner as to cause the Note to be treated as "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended (the "Code"). The City covenants that it will submit to the Secretary of the Treasury of the United States, not later than the 15th day of the second calendar month after the close of the calendar quarter in which the Note is issued, a statement as required by Section 149(e) of the Code. The City represents that it has not used or permitted the use of, and covenants that it will not use or permit the use of the proceeds of the Note, in such manner as to cause the Note to be "private activity bonds" within the meaning of Section 141 of the Code. The City covenants that it will take no action which would cause the Note to be "federally guaranteed" within the meaning of Section 149(b) of the Code. Nothing in this Article shall prohibit investments in bonds issued by the United States Treasury.

Section 8: In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this Ordinance is declared or adjudged to the be invalid or unconstitutional, such declaration or adjudication shall not be affect the remaining portions of this Ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this Ordinance.

**Section 9:** All ordinances or resolutions of the City in conflict herewith are hereby repealed to the extent of such conflict.

**Section 10**: Funds provided through the issuance of the Note are hereby appropriated and budgetary authority is provided for the Project in an amount up to \$4,000,000.

**Section 11:** Funds provided shall be appropriated from the General Fund – Loan Proceeds account (001.119.4370) into the Machinery and Equipment account (001.131.5910) and Computer

Equipment/Software Account (001.125.5930) as money borrowed and received for the Project in an amount of up to \$4,000,000.

**Section 12:** This ordinance is necessary for the protection of the public peace, health and safety and that in order to avoid project delays to this Project, it is essential to the ability of the City to efficiently conduct business and have the necessary funds to pay for this Project and therefore, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
