

**AN ORDINANCE APPROPRIATING FUNDING AND AUTHORIZING THE RENTAL OF PROPERTY LOCATED AT  
611 COURT STREET, SUITE 6; AND FOR OTHER PURPOSES**

**Whereas**, the Conway Police Department needs additional space for operations, in order to better serve the community and meet the growing demands; and

Whereas, Conway Police Department has identified a neighboring property located at 611 Court Steet, Suite 6 as a suitable location; and

**Whereas**, the property is available on a yearly lease agreement for rent at a rate of \$800 per month, which is deemed to be a fair and reasonable market rate; and

**Whereas**, the funding has not been appropriated for this purpose.
