Whereas, The Department of Energy (DOE) has made funding available through the Energy Efficiency and Conservation Block Grant Program; and

Whereas, the City of Conway is eligible to apply for formula funding, allocated by the DOE, for up to \$125,490.00 not requiring any matching funds; and

Re: Request to waive the 12-month waiting period before a rezoning request may be submitted after Planning Commission denial

Jamison Bonds, property owner at 3310 Prince Street, has requested the waiver to submit an amendment application to the Planning Commission to rezone the lot from R-1 (Single-family Residential District) to R-2A (Two-family Residential District), with the additional request of a conditional use permit to allow the Office - Restricted use for his legal practice.

If approved by a two-thirds majority, the applicant must adhere to all applicable rezoning requirements such as applications, fees, and public notice requirements. The item would be heard by the Planning Commission after all submittal requirements are met. If approved by the Planning Commission, the rezoning and condition use permit request will be forwarded to the City Council for consideration.

At the September 16, 2024, meeting of the Planning Commission, the applicant's request for a rezone from R-1 to O-3 was denied. There was considerable public opposition to the consideration and the applicant wishes to develop the site under a different zoning classification as well as request consideration for a conditional use permit to allow Office - Restricted use. The Zoning Code prohibits a rezoning application within one (1) year from the effective date of final denial action unless authorized by the City Council.

Staff recommendation: Staff recommends **APPROVAL** of the request.

Dear Members of the Planning Commission:

I am writing to follow up on our communications about the rezoning of 3310 Prince Street and to ask for your assistance.

We originally requested the Planning Commission to allow the rezoning the Property from R-1 to O-3 in order to give our small Estate Planning and Elder Law firm a permanent place to call home.

Unfortunately, the request was denied by the Planning Commission at the public hearing held on September 16, 2024.

During the hearing, discussions occurred appearing in support of our position that the property is likely not desirable or suitable as a single-family residence, but that O-3 rezoning was too broad of a change. Instead, it was suggested that requesting rezoning to R-2-A with a conditional use permit, to use as a quiet office, as proposed, could be a more viable solution.

For those reasons, we are asking for a place on the next agenda for the Planning Commission and asking council to waive the 12-month moratorium to hear a rezoning request on 3310 Prince Street in accordance with Section 8.305-D of the Zoning Code of the City of Arkansas.

If the moratorium is lifted, we intend to move forward with a request to rezone R-2-A and seek approval for a conditional use permit. Thanks for your assistance and consideration.

Re: Request to waive the 12-month waiting period before a conditional use request may be submitted after City Council denial

Jared Coleman of Blue Whale Development, one behalf of owners William and Patricia White, has requested a waiver to submit an amendment application to the Planning Commission for a conditional use permit to allow the Retail - General use.

If approved by a two-thirds majority, the applicant must adhere to all applicable conditional use permit requirements such as applications, fees, and public notice requirements. The item would be heard by the Planning Commission after all submittal requirements are met. If approved by the Planning Commission, the conditional use permit request will be forwarded to the City Council for consideration.

At the May 20, 2024, Planning Commission meeting, the applicant's request for a conditional use permit was approved. There was some public opposition to the consideration from both nearby residents and local business owners due to the proposed use being that of a coffee shop with drive-through. At the May 28, 2024, City Council meeting, the applicant's request for a conditional use permit failed, with a vote of 4-4.

The applicant wishes to again request consideration for a conditional use permit to allow the Retail - General use, but is proposing a restaurant (without a drive-through). The Zoning Code prohibits a rezoning application within one (1) year from the effective date of final denial action unless authorized by the City Council.

Staff recommendation: Staff recommends **APPROVAL** of the request.

On May 28, 2024 the City Council of Conway denied Blue Whale Development's Conditional Use request for 2555 & 2656 Prince Street, Conway, AR 72034. Blue Whale Development recently attempted to submit another Conditional Use Application on September 20, 2024 however City Staff has recently informed us of Zoning Code Article 802.6B(3) "A conditional use application may not be filed for a site that has received final denial action within one (1) year from the effective date of final denial action unless authorized by the City Council."

Since the May 28, 2024 City Council Meeting

- Blue Whale Development has identified an alternate use for the property (Casual Dining Restaurant Serving Pizza, Burgers, Wings and Craft Beer with a spacious outdoor patio along Tucker Creek Trail – No Drive Thru Service)
- Blue Whale Development has also worked through an agreement with Shadrach's ownership on the shared use of a curb cut off of Prince Street.

Due to some of the existing conditions under Conditional Use Permit Number 1277 these items could potentially prohibit the feasibility of this project to continue. We are asking City Council to waive the moratorium and allow for Rotolo's CUP Application, CUP-0924-0127 to be heard on the November 18, 2024 Planning Commission Date.

We appreciate your consideration in helping to resolve this matter allowing us to move forward with submitting our application.
