Ordinances Passed:

- O-14-34 Ordinance appropriating reimbursements funds from various entities for the Conway Police Department. **Vote 7-0**
- O-14-35 Ordinance appropriating asset forfeiture funds in the amount of \$5,000 for various departmental training & annual conference membership dues for the Conway Police Department. **Vote 7-0**

- Approved Authorizing the Mayor to proceed with a termination letter to Cope Aviation for the buyout of the current FBO agreement at the “old” Conway Municipal Airport. **Vote 7-0**
