**Ordinances Passed:**

- O-14-57 Ordinance accepting and appropriating grant funds received from the Central Arkansas Planning and Development District in the amount of \$133,034 awarded to the Conway Police Department for the Conway Airport Security System. **Vote 7-0**
- O-14-59 Ordinance to approve donation of computer hardware to Conway Public Schools. **Vote 6-0**

**Ordinances Failed:**

- O-14-58 Ordinance to rezone property located at 1601 Greenwood Circle from R-1 to R-2A. **Vote 0-6**

**Resolution Passed:**

- R-14-16 Resolution setting a public hearing for July 8<sup>th</sup>, 2014 @ 6:30pm to discuss the closing of a 15 foot utility easement located in Trinity Washington Subdivision, Phase II. **Vote 7-0**
- R-14-17 Resolution authorizing the City Attorney's Office to seek condemnation for property owned by Dave & Darla Haas/Jordan & June Haas for the Favre & South Donaghey Roundabout project. **Vote 7-0**

**In Other Actions:**

- Approved In committee the conceptual site plan provided by Collette; additional details will be forthcoming from the AR Hwy Dept. This deal is conditional on the bond issue in September passing; and the City will be responsible for engineering cost associated with this project. **Vote 7-0**
- Approved June 10<sup>th</sup>, 2014 City Council Minutes. **Vote 7-0**
- Approved Change Order No. 1 in the amount of \$25,455 for the onsite sanitary sewer system for the new Conway Municipal Airport. **Vote 7-0**
- Approved Monthly Financial Reports ending May 31, 2014. **Vote 7-0**
