## City of Conway -- City Council Brief January 23, 2007

At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-07-05} appropriating funds in the amount of \$6,360 for the YSAC (Youth Softball Association of Conway) to help purchase equipment. **Vote 7-0 w/ Alderman Hawkins absent**
- Ordinance {O-07-06} appropriating funds in the amount of \$15,843 for the wastewater lift station and force main for Animal Welfare. **Vote 7-0**
- Ordinance {O-07-07} appropriating asset forfeiture funds in the amount of \$5,985 for National Law Enforcement Accreditation fees. (CALEA) **Vote 6-1 w/ Alderman Vaught voting against.**
- Ordinance {O-07-08} waiving bids and providing sole source vendor status to Motorola for all radio equipment for the City of Conway. **Vote 7-0**
- Ordinance waiving bids and providing sole source vendor status to Business Network Solutions for a six months period with an hourly rate of \$65.00 to provide network support and system network for the City of Conway. **Vote 7-0**

- ♦ Approved entering into a contract with Mr. Jim Hays of Business Network Service for a period of six months to provide network support for the City at an hourly rate of \$65.00. **Vote 7-0**
- ♦ Approved transferring funds in the amount of \$ 33,280 from part time labor to contract labor to provide funds to compensate Mr. Jim Hays of Business Network Solutions for network support. **Vote 7-0**
- ♦ Approved sidewalk variance for property located at 4965 College Avenue. No sidewalks will be required at this time. **Vote 7-0**
- ♦ Approved not to terminate the wrecker contract and to accept payments from the Helton Wrecker Service (Bill Helton) & Pro Auto Wrecker Service (Neal Ross). **Vote 6-2 w/ Alderman Smith & Hawkins voting against.**
- ♦ Approved three percent cost of living raise for Department head & elected officials; (excluding City Council); Planning Director Bryan Patrick & Parks Director Brian Knopp receive slightly higher raises to match similar positions. **Vote 7-0**
