City of Conway -- City Council Brief
April 24th, 2007

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-07-44} rezone the property located at the southeast corner of College Avenue and Hubbard Road with the property address of 2611 College Avenue from R-2 to MF-2. **Vote 7-0 w/ Alderman Mehl not present.**
- Ordinance {O-07-45} rezone the property located at 1912 Caldwell Street from R-1 and R-2A to HR **Vote 7-0**
- Ordinance {O-07-46} amending the Old Conway Design Overlay District ordinance for the City. **Vote 7-1 w/ Alderman Vaught voting against.**
- Ordinance {O-07-47} to reduce fees for one day at the City of Conway Sanitation Department for county residents to coincide with the 2007 Great American Spring Cleanup Event. **Vote 8-0**
- ◆ Ordinance {O-07-48} appropriating donated funds in the amount of \$1910 from various organizations for equipment at the training site for the Conway Fire Department. **Vote 8-0**
- Ordinance {O-07-49} appropriating donated funds in the amount of \$1000 from First State Bank and appropriating \$700 for (2) competition manikins for the Conway Fire Department. **Vote 8-0**
- Ordinance {O-07-50} appropriating asset forfeiture funds in the amount of \$ 4,306.78 to various department to comply with the 2003 agreement with the Conway Regional Drug Task Force and other local agencies. **Vote 8-0**
- Ordinance {O-07-51} appropriating funds in the amount of \$7,530 for the network engineer staff for the CEOC. **Vote 8-0**
- Ordinance {O-07-52} waiving bid for the purchase of 40 yard dumpsters from Linn Paper Stock. **Vote 8-0**

- ♦ Approved entering into an agreement with the University of Central Arkansas for the rental of Jefferson D. Farris Jr. Softball fields for 2007. *Vote 8-0*
- ♦ Approved bids submitted for a front end loading refuse truck by Barloworld in the amount of \$180,487 for the Conway Sanitation Department. *Vote 8-0*
- ♦ Approved bids from Deerskin Mfg, Inc. in the amount of \$28,500 for a custom built adoption trailer for the Conway Animal Welfare Unit. *Vote 8-0*
- ♦ Approved the addition of a network engineer on the existing pay grid for the CEOC. *Vote 8-0.*
- ♦ Approved the acquisition of a new postal machine from Pitney Bowes for the Conway Finance Department. *Vote 8-0*
