At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-07-53} reducing the existing 15' feet utility easement running along the East side of the Lot 184 Westin Park Subdivision, with a property address of 330 Esplande Avenue by five feet. **Vote 8-0**
- Ordinance {O-07-54} calling and setting a date for a special election of the issuance of bonds for the purpose of city park facilities. **Vote 8-0**

- ♦ Approved minutes from the April 24, 2007 City Council meeting. **Vote 8-0**

- ♦ Approved a parking lot variance for Lindsey's Barbeque of Conway for property located at the southwest corner of the intersection of Markham and Mill Street. **Vote 8-0**
- ♦ Approved a conditional use permit for CDC for property located on South Amity Road, immediately west of Schlumberger Technology Corporation site in Guy Murphy Industrial Park to allow the storage and sale of petroleum products. **Vote 8-0**
- ♦ Approved a request by Stewart McConnell to place certain aspects of the entry feature within the public right of way at Spencer Mountain. **Vote 8-0**
- ♦ Approved an agreement for professional services from Carter & Burgess, Inc. for developing a master plan for the girl's softball complex and general park facilities for the Bob Courtway/Siebenmorgan City Park for \$30,380. **Vote 8-0**

- Consideration of a conditional use permit for MF-1 density in an R-2 zone for property located at 308 Salem Road for Roy Massey. *Vote 8-0*
- Consideration of a roundabout at Prince Street – Western Avenue. *Vote 7-1 w/ Alderman Hawkins voting against item being held in committee.*
