At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-07-87} authorizing the donation of ball field lights from the Parks and Recreation Department to the City of Mayflower and City of Menifee. **Vote 8-0**
- Ordinance {O-07-88} approving the spending of Park Impact Fee Revenue monies to pay down principle balance on First State Soccer Park loan. **Vote 8-0**
- Ordinance {O-07-89} offering reduce rates at the City Sanitation Department for the Faulkner County Solid Waste District for a one day event on September 8th, 2007. **Vote 8-0**
- Ordinance {O-07-90} appropriating revenue funds in the amount of \$8,290.09 to the Conway Animal Welfare Unit. **Vote 8-0**
- Ordinance {O-07-91} waiving bids, utilizing a sole source vendor (Southern Software), and appropriating funds in the amount of \$353,145.28 to replace public safety software for the City of Conway **Vote 8-0**
- Ordinance {O-07-92} appropriating funds in the amount of \$8,000 for the rental of a scaffold for the mural project at City Hall. **Vote 8-0**

- ◆ Approved a boat dock permit for William Gillespie with property located at 30 Hwy 25N on Beaverfork Lake. *Vote 6-2 w/ Alderman Vaught & Mehl voting against.*
- ◆ Approved the buy out of Ed's Supply lease for property located at 600 & 618 Front Street in the amount of \$33,698. *Vote 5-3 w/ Alderman Vaught, Bell, Smith voting against*
- ◆ Approved a recommendation from the Tree Board Committee to remove the cedar tree in Simon Park to a different location. *Vote 8-0*
