At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-07-154} appropriating revenue funds in the amount of \$300 to the Conway Tree Board. *Vote 7-0 w/ Alderman Whitmore not present.*
- Ordinance {O-07-155} appropriating revenue funds in the amount of \$2,428 to the Animal Welfare Department. *Vote 7-0*
- Ordinance {O-07-156} appropriating grant proceeds from the Office of Justice Programs and appropriating funds in the amount of \$16,627 for the Conway Police Department. *Vote 7-0*
- Ordinance {O-07-157} appropriating funds in the amount of \$4,800 for building additions in regards to building improvements to the Conway Fire Department. *Vote 7-0*
- Ordinance {O-07-158} providing for the restrictions on novelty lighters for the City of Conway. *Vote 7-0*
